John Flower - his neighbor Albert Phelps dogs are barking all the time. Terry Dopp - we have come to as the Town for help, the dogs' bark the whole time Albert isn't home. John Flower - he tried to talk to Albert, Albert was very obscene, he's unstable, John feels bad for the dogs, Albert doesn't seem to care, he's losing his home. Supervisor Tanya Yerdon - asked how many dogs? John Yerdon - Dog Control Officer has had several calls regarding these dogs. John Yerdon - talked to Albert - the dogs don't have any shots or licenses, he told Albert if he picks them up its \$ 25 per dog, \$5 per day at the kennel, after 5 days he would put them down and charge Albert for that, it would be probably \$ 300, John suggested a 5 foot chain for each dog, one in each corner of a small shed he has in the back. Albert doesn't have a job, is losing his home, he's not in a good

place. John Yerdon agrees with John Flower on his assessment. John Flower - Albert did make some threats, killing people, the whole town. John Yerdon - heard some of the same comments, all of his neighbors and NYS. Supervisor Tanya Yerdon - will contact the Oswego County Sheriffs or the NYS Troopers, this can't be taken lightly. John Yerdon - agrees something needs to be done, he told him he tried to get a neighbor to take him for groceries this winter, no one would so he ate dog food , in another month he will start working for Salmon Season, doesn't think we can wait, need to do something now. Terry Dopp - can the Town Board give John Yerdon - Dog Control Officer authority beyond or a motion to give him more authority, he has a hard time calling the Sheriffs on him. Supervisor Tanya Yerdon - the Town needs a noise ordinance, but they don't work, Authorities won't act on them, they can only go so far off the street. CW E. Yerdon - they talked about it a long time ago, who's to tell how many decibels, etc. Terry Dopp - dogs barked until 2:30 am. John Yerdon suggested a chain in the back building, put something over the windows, the female is going to be coming into heat soon. Terry Dopp - he's already had 2 litters. John Yerdon - gave him to the end of the month, John will pick them up if nothing happens. Teresa Dopp- the dogs are friendly. Supervisor Tanya Yerdon - will he surrender the dogs? John Yerdon - he's raised them from puppies. John Flower - it's the only family he has. John Yerdon - gave him till the end of the month, he will stay on top of this. Supervisor Tanya Yerdon - would you put what happened in writing? There was discussion. John Flower, Terry Dopp and Terri Dopp left the meeting at 7:50pm.

CODE ENFORCMENT OFFICER - MICHAEL YERDON

Mike's monthly report was handed out, it's been a busy month, he's been doing some inspections. On Thursday he will be in Syracuse for a training class on Fire Safety Design. CW E. Yerdon - asked how do you tell when the permit is done? Mike explained the report, the Certificate of Occupancy.

HIGHWAY SUPERINTENDENT - PAUL PRATT

Paul - they are done paving the Teachout Road, they will oil and stone next week. They have hauled 50 loads of sand from Osceola, the invoice was in the vouchers. Saturday night a beaver dam washed out on the Kay Road, it pushed the concrete blocks way into the ditch. Paul asked Oswego County - Kurt Osphelt for help, the Town doesn't have any equipment big enough to get down in the ditch. The road mower is down - the bear box on the back isn't working, didn't know if it was just the seals, both the seals and bearings are gone, the shaft that goes in there can't get the part, Halsey's has checked - Alamo - says the part hasn't been available for a long time. The road mower and Gradall are getting towards the time to retire them, they are both over 30 years old.

We could take the mower off and possibly get some money for it. He hasn't checked any figures but it would be over \$ 100,000, Osceola bought a used one for \$ 65,000 but we should have a little bigger one, need for next year. Angie Kimball - Tug Hill Commission - Senator Patty Ritchie/Assemblyman William Barclay have a SAM Grant through the Dormauthority, she would help with the paperwork, could be worth a shot.

ASSESSOR - JANE JONES

Jane has an upcoming small claims hearing regarding the Florence Parkhurst property, she hasn't gotten a date yet but it has to be done before the School Taxes come out.

DOG CONTROL OFFICER - JOHN YERDON

John has a new list of 5 or 6 dogs to go check on.
