Special Meeting was called to order at 6:32pm by Supervisor Tanya Yerdon. Supervisor Tanya Yerdon - there are no comments to discuss on the proposed Local Law #1 of 2020 A Local Law Opting Out of the Tax Exemption Under Real Property Tax Law §487, does the Board have any questions or concerns. Mike Yerdon - would like Nuclear and County of Oswego put back in the sentence " Further, there are existing hydroelectric, **nuclear** and other generational assets within the Town of Redfield and **County of Oswego** which already are on the tax rolls, employee residents and face transmission constraints to market which must compete with new energy systems covered by RPLT§487. Mike - it has a direct impact on the Town of Redfield because of the County Taxes. CM M. Tompkins - also the same sentence should read employ not employees residents, likes Mike's additions. CW E. Yerdon - is good with it, we can't legislate but thinks that sentence would be ok.

Supervisor Tanya Yerdon- We will audit the Clerk and Supervisor Books at a later date due to the Executive Order, CW Suz Yerdon has audited the Clerk's books and has the Supervisor's books now. Highway Superintendent - Russell Montieth - Delong did an excellent job on the 2007, the guys have been working on the dump box which is coming good. The insurance company has a ten year lump together replacement, they are going to separate the 2007 out so it's covered because it almost makes it a new truck.

Supervisor Tanya Yerdon - due to the COVID-19 - the Offices will be closed until further notice as the Governor has ordered distancing and all non-essential businesses close and to work from home when possible. Tanya and Russell have discussed this about our crew, the other Towns are getting paid 40hours, they are on call, they will not automatically get paid eight hours if they are not available when they are called in, Russell called them in on Monday and Tuesday. The County is off until April 14, 2020. There was discussion regarding what the State is doing with their crews. Russell has a culvert on the Waterbury Road that needs to be replaced and having beaver problems. Tanya - this is all unknown and we will just have to work it out as it comes. We are all on call, all of our phone numbers are out there if someone needs to get in contact with us. Pathfinder bank is not charging monthly fees for Municipalities, the letter should not have been sent out. We will need to find out Pathfinder's hours for deposits. Susan will contact Shania and find out. Russell - there are tree limbs down in the back corner section of the Cemetery, a bad spot in the road going in from the fill. CW E. Yerdon - there are some trees that are bad and that need to come down, an old maple, one by the gate on Brockway's end. Tanya - we need to take this serious. CW E. Yerdon - Lenny has taken down trees in the past over there. CM M. Tompkins - roadway and cemetery should be re-visited when residents can attend.
