Eric Gantley - Pennock Brook Subdivision

Mr. Gantley passed out a revised map, they changed the property line for the 30ft, new septic has been engineered - added another line on it, had the actual survey which is now 2.9 acres it was 2.6 acres. Code Enforcement Officer - Michael Yerdon - they did get a building permit and a COC can be issued as soon as Mr. Lasell - (Engineer for the septic system) gives Mike the paperwork needed. CODE ENFORCEMENT OFFICER - MICHAEL YERDON

Mike - not much has changed since last month. He will have 5 more permits by next month. Ryan Road has a doublewide going in and another one with a 600+ foot driveway, Mike Lasell is the Engineer for both of the septic systems. The one is determined to get in there by winter, can't see that happening. CM M. Tompkins - it's against the NYS Health Department to install a septic system in frozen ground. Mike - COVID increased construction, will be over 60 permits

this year. The Hayloft under new management/owners - they requested a COC (Certificate of Occupancy) - Mike supplied them with the original, he will be completing an Occupancy Load soon.

COUNTY LEGISLATOR - MICHAEL YERDON

Mike - the County has been working on the 2021 Budget, \$ 7.54 per \$ 1,000, they were cautious in lowering the budget, wanting to make sure they would not be short with the twenty percent reduction from the State. They put a freeze on wages, hiring, purchasing, spending in March. Unless it's required to operate the department they needed approval from the Legislature, froze until next April, with the COVID program they had to spend funds. It's been an interesting year, should finalize the budget in December, they will combine a public hearing for the budget and the regular meeting, they had a remote meeting this past month, pretty quiet.

HIGHWAY SUPERINTENDENT - RUSSELL MONTIETH

Russell - ordered the new truck, had copies of the invoice, it's a work in progress to get an idea when Viking will want it and delivery date. Insurance Company -Police report was released, two days of calling, email conversations - the case is closed. The check amount was \$ 2,788.08 with the \$250 deductible. Monroe Tractor contacted Russell to demo a road mower, Dale and Russell were the only ones there, he did over by the well and he saw something thrown up into the woods - it was the battery charger that had been stolen and the jack. He called the Sheriff's department - can't get any prints off them due to being out in the weather - lots of water in the charger. Russell, Tanya and the Sheriff and the guys all walked the woods, the jack was back by the snowmobile trail - obviously too heavy, the charger over by the cold storage building. The road mower is a 2012 Case with 4500 hours on it, looks and runs decent, too much to it, rear mount, long arm. On Monday morning the head wouldn't turn on, hasn't heard back from anyone at Monroe Tractor, Dale took a message that we were morons and didn't know what we were doing, they would have a mechanic there at 8am, Russell's done with them, not happy with them - \$ 80,000 for unit. 2018 Kubota \$ 89,400, 500 hours- Russell told them they had to do a lot better than that. The machine wasn't feasible - would have to do two passes, it was very slow. Supervisor Tanya Yerdon - at least you got to try it out and see what you did and didn't like. Russell - sander/plow unit - new hydraulic lines, fittings, couplers, got things straightened out, can load the sander without it being on, changed the quick couplers to high pressure couplers, better than what we were buying, Instrument Panel - most dash lights were out, \$ 900 plus shipping for new one. Tanya and him did the CHIPS report on Monday and sent it in. Received confirmation that they received it. PAVENY is very specific and could only send bills in at 80%, almost \$ 58,000 left. New headlights on the 2014 - \$ 200 - \$ 300 for the cheap plastic ones, bought new heated LED for \$ 400. County Solid waste - will send a questionnaire out in January regarding an organic compost - wanted to know how much material we picked up, they were kind of surprised we don't pick up.

TUG HILL COMMISSION – ANGELA KIMBALL

Angie - the Town of Pinckney has approved their Special Areas map. The assessor training at Tailwaters has been cancelled. A reminder that the Sexual Harassment is due - it's annual training.

SUPERVISOR - TANYA YERDON

Supervisor Tanya Yerdon - received the Shoulder Machine Municipal Cooperation Agreement, they did make the changes requested, and the machine will be housed in Sandy Creek. The tax cap audit went good. Preliminary Budget - we increased the machinery and unexpended fund balances by \$ 20,000 at the last meeting.

Motion was made by Tanya Yerdon and seconded by Erwin Webb to authorize Town Clerk Susan Hough to advertise there will be no parking on town roads in the Town of Redfield from November 1, 2020 to April 15, 2021 between the hours of 12:00 midnight and 6:00a.m. There will also be no parking in snowplow turnarounds at any time of day between the aforementioned dates and no parking at any time in school bus turnarounds. Vehicles illegally parked will be towed away at the owner's expense and to advertise that the Town of Redfield will not be liable for any damage to vehicles and/or personal property, including mailboxes that are within the Town's right of way during the process of plowing and removing snow.

CW E. Yerdon - Have you gotten anyone to fill the Dog Control Officer position? Supervisor Tanya Yerdon - she has a call into Clayton Conover. Angie - she thinks he's the III, Williamstown and Florence are very happy with him, they had hundreds of dogs licensed after the enumeration. Supervisor Tanya Yerdon - the AGs & MKTs woman called and wanted an update - she understands our situation and said to take our time and call her when we have more information. CW E. Yerdon - where does he live? Angie - Vienna - his father is the Highway Superintendent. CW E. Yerdon - has the briefcase with the forms, etc.

Motion was made by Erwin Webb seconded by Matthew Tompkins to adjourn the meeting at 8:56pm.
