We had 2 DECALs, 4 Dog Licenses, 1 Death Certificate. TC S. Hough opened the sealed bids received for the Propane, Gas and Diesel bid. Glider Oil – Propane \$ 1.749, Ultra Low Diesel \$ 2.6974, Kero \$ 3.2823 and Gas \$ 2.85. Superior Energy Services – Propane \$ 1.43.

CODE ENFORCEMENT OFFICER – MICHAEL YERDON

Mike has done 22 permits with 2 more coming in, averaging 2-3 at a time moving along, same speed as last year.

OSWEGO COUNTY LEGISLATOR – MICHAEL YERDON

Had opening day at Zerbie camp – goes for 6 weeks, children 12 and under, had 30 kids. Upgrading the bath House \$ 350,000, a grant from Will Barclay of \$ 50,000, they've hired an Engineer. Legislature meeting Thursday, Redfield Sow Club grant in the amount of \$ 70,000 for their new project/building has passed through the Committee's so far and will be voted on Thursday. They reviewed the exemptions for Fire Department members and changed the qualification from 5 years to 2 years, hoping for approval and public hearing.

ASSESSOR - NICK SMITH

Mick – the State has removed 34 Basic Star exemptions; they do not give him a reason. The Final Roll is completed and issued. He will be attending a class on August 11th.

HIGHWAY SUPERINTENDENT - RUSSELL MONTIETH

Russell - pavement is completed - Orwell, Boylston and Williamstown, Amboy is not completed yet. Chip Sealing tomorrow in Redfield, the 17th and 18th will be chip sealing in Boylston. Have spent \$ 121,000, hoping to do a second seal on the Waterbury Road, \$ 24,000 for oil. Sandy Creek received the new Road Broom - minor concern but they will take care of it. Orwell and Boylston sent the checks for the old Broom – will still be able to use if needed. Russell has added it to our insurance. Mowing the Town properties and cemeteries - Wendy will not be able to mow the rest of the season – he would like to continue with Brad and Jaeden Darling. They have 2 culverts to replace - Harvester Mill and Clark roads. There hasn't been any action by the Committee or Legislation on the Snow and Ice Contract. Ann Stacy has taken lead for the Town Supervisors, talking about a deadline, asking for \$ 10,000 per mile, they don't want to wait until October, proposed \$ 10,000 last year settled on \$ 9,000. Steve Walpole has resigned from the Committee, Paul House taking over for the Committee, thoracically contract is between the County and Town, last year had meetings by this point. Russell asked Mike if he has heard anything and he has not. CM C. Yerdon asked Mike to look into it. Mike will have an answer in a couple of weeks. Road Mower on Auctions International - had 1900 hours and had emissions problems - new motor has 600 hours with no issues had seals brake output shaft issue. CW C. Bauer – asked Russell if he has been up to look at mower? Russell – no – Superintendent said it's been a great machine, some tire wear but nothing that needs replacing soon. CM C. Yerdon – how much money is in the budget? There was discussion.

Supervisor Matthew Tompkins – we need to put the Garbage Contract out for bid – language to be added to the contract – No Fuel Surcharges. Discussion regarding the Garbage Contract and containers, dump day.

Supervisor Matthew Tompkins – The Welcome to Redfield signs – if put on the County Roads would need 8 signs – Matt will look into them. CM C. Yerdon – we need to look at the Snowmobile Law and review the open roads. Supervisor Matthew Tompkins will put on the August agenda. CM T. Harlander – need to look at the building demolition procedure and agree on wording for requirements. Supervisor Matthew Tompkins – need to have a fee schedule – sill put on the September agenda. Angie – look into a Board for Variances.

CTHC CIRCUIT RIDER – ANGIE KIMBALL

REMINDER: The Tug Hill Commission has obtained a MetroCount MC5900 Series Roadside Unit with related software for computer desktop analysis available for the use of any of our Tug Hill municipalities, free of charge. The MetroCount system collects data on vehicle counts, speed, class, direction, flow, spacing, etc. These metrics can be compiled into reports, summaries, and graphs. Commission staff will set-up the equipment for one week and retrieve it from a municipality specified location. If your highway department is interested in commission staff facilitating the collection of road data to produce vehicle and traffic data reports, fill out the form HERE and contact Gabriel Yerdon at the Commission office at gabriel@tughill.org or 315-785-2387 for help or any questions. REMINDER: The 2023 Consolidated Funding Application (CFA) is now open! Some of the funding programs available are the Community Development Block Grants (CDBG), Environmental Protection Funds for Parks, Preservation and Heritage, the Recreational Trails program, the Local Government Efficiency program, NY Mainstreet grants, the Local Waterfront Revitalization program, Climate Smart Communities grants, Water Quality Improvement Program (WQIP) and many more. The deadline to apply for a CFA this year is Friday July 28th at 4 p.m. Contact your circuit rider if you have a grant in mind and need help. REMINDER: Round 3 of the Regenerate New York Forestry Cost Share grant program is available now. The purpose of this grant program is to support the regeneration of forests so they may continue to deliver vital services such as mitigating climate change, protecting air and water quality, and supporting the economy. Young forests in New York face many challenges today that did not exist a century ago and active management of the land is essential to ensure the survival of young trees and allow forests to become established or renew themselves. Regenerate NY is a cost share reimbursement program, so applicants would pay the costs upfront and be reimbursed 75% of the costs. Eligible applicants must have at least five acres and complete one of four eligible projects. Minimum grant award is \$10,000 and maximum is \$100,000. Applications must be submitted through the Grants Gateway and will be accepted through October 6th or until they exhaust their funding, whichever comes first. For more information visit
